RE-CHECKING AND RE-ASSESSMENT RULES

1. In case a candidate who has appeared for the University Examination is not satisfied with the assessment of his/her answer-books in any paper/s he/she may apply for Re-checking/Re-assessment for his/her answer-books in the prescribed form of application to Registrar, Raksha Shakti University, Ahmedabad.
2. No application for re-checking/re-assessment of marks/grades obtained at the Internal Test/Practicals, Mid-term, Viva-Voce, Thesis, Dissertation, project, etc. shall be entertained by the University.
3. The application form for Re-checking/Re-assessment will be available from the Examination Section. The student have to pay the fee of Rs. 150/- per Paper for Re-checking and Rs. 1000/- per Paper for Re-assessment on or before Ten (10) working days from the date of declaration of statement of marks of the concerned Examination. The completed form and paid fee receipt must be submitted to the Examination Section of the University Office in stipulated time.
4. Re-checking is permitted in all semesters of all courses for all subjects. In Re-Checking, Answer books are checked just to ensure that all the questions attempted by the candidate have been valued, the marks awarded have been totally corrected and the total marks have been correctly carried over to the result statement.
5. The application for reassessment will be accepted for all subjects per semester of the concerned Examination.
6. The application received after the due date or not accompanied with fee receipt, the Original Statement of Marks and other details required in the prescribed application form shall not be entertained and no correspondence in that respect will be entertained by the University.
7. The Registrar in consultation with a concerned subject expert, as may be deemed fit by him will appoint one Examiner other than original assessor to reassess the answer-book in the subject concerned:
 - a) If as a result of Re-assessment, the difference between the original assessment and re-assessment is 10% of the original obtained marks in paper, no modification in the original marks shall be made.

- b) In case of Grades if after Re-assessment the Grades obtained are the same as originally obtained by the candidate, there will be no change in the Grade.
 - c) If a result of reassessment the difference between the Original assessment and the reassessment by the examiners appointed exceeds 10% of the obtained original marks of the paper, the answer-books of the concerned subject will be sent to another examiner who will act as moderator for reassessment.
 - d) If on Re-assessment, there is a change in the Grade, the final grade obtained after Re-assessment will be finalized.
8. Once Application for Re- assessment/Re-Checking have been made by the applicant, no fees will be refunded to the student,
 9. The candidates applying for reassessment shall give an undertaking in writing to the effect that the result of reassessment of his/her answerbook/s shall be binding on him/her and that he/she shall accept the revised marks and the result either negative or positive or remained unchanged.
 10. Till such time as the result of reassessment of answerbooks applied for is communicated to the candidate, the original result of the candidate shall be considered unchanged for all purposes.
 11. If the modified result due to reassessment of answerbooks is declared after the commencement of the academic term, the candidate shall be eligible to seek admission to the higher class in accordance with the relevant Ordinances, rules and regulations framed by the University in that behalf from time to time and no claim will be made for making any relaxation in academic requirement for that higher class.
 12. The result of reassessment will be declared as far as possible within a period of six weeks from the last day fixed for the receipt of the application for reassessment.
 13. The new scheme of reassessment be made effective from 2015-16 Academic year.
 14. The Examiner appointed for Re-assessment should be paid the remuneration of the checking of answer books as per existing university rules.
