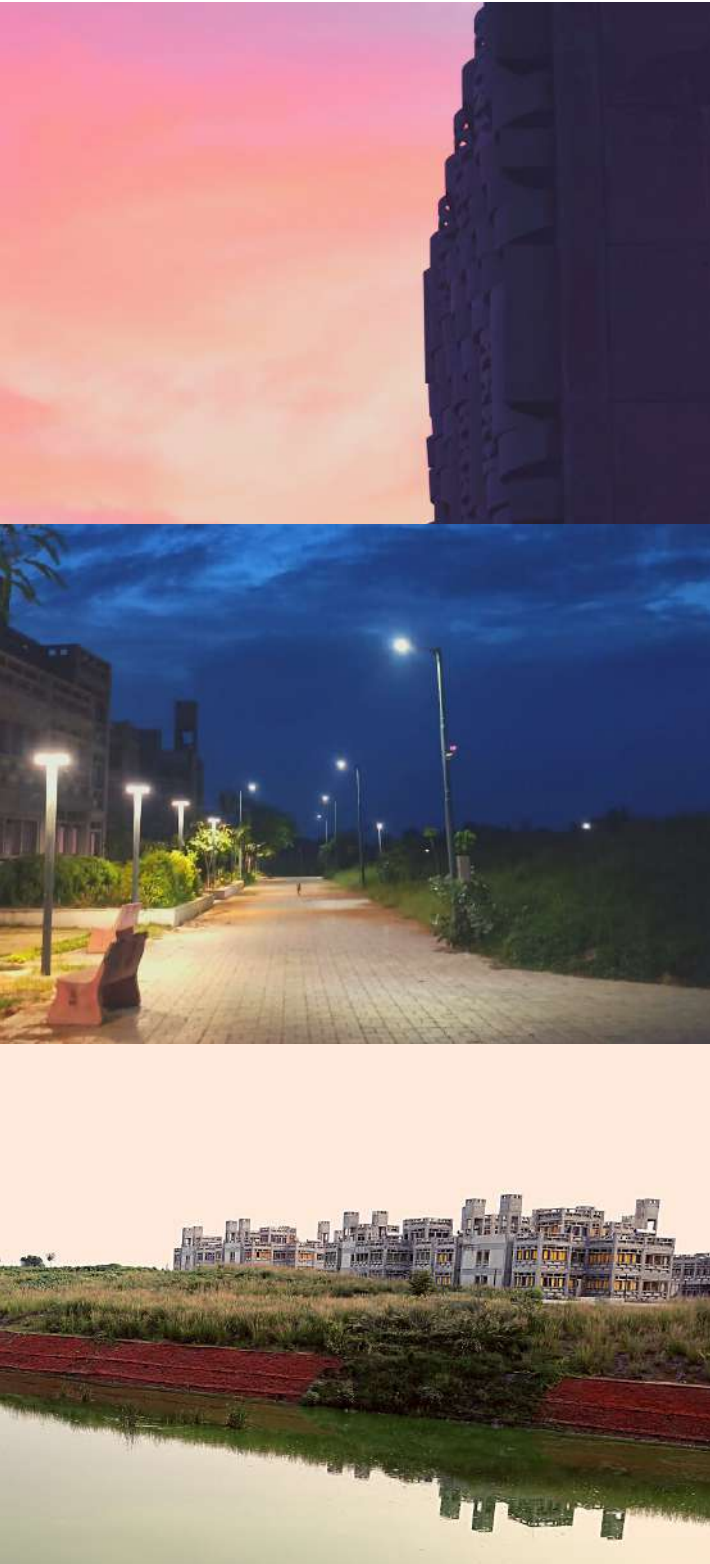

BEYOND CLASSROOMS

SLHSS organizes several academic exercises in the form of Expert Lectures, Conferences, Seminars and Workshops for Students, Faculties and Research Scholars. Such events are witnessed by all the stakeholders of criminal justice system, viz- Judges, Advocates, Police officers and also academia.

SLHSS also supports its students with internship facilities at various government organizations of repute viz, BPR&D, NCRB, NHRC, SHRC amongst other national and international institutions of repute

SLHSS also has a dedicated wing for placement of the students and also a centre to prepare them for various competitive examinations.



LEARNING RESOURCE CENTRE (LIBRARY AND DATABASE)

SLHSS has access to the Central Library of Rashtriya Raksha University which aptly boasts of 4,300 sq. ft. having reading capacity of 120, 800 users, and supporting teaching, research and extension programmes of university. The library has rich collections of books, print periodicals, and journals in the field of technology, arts, law, criminology etc. The Central Library also stands as a unique centre of knowledge which offers access to specialised information. There are several e-resources viz EBSCO, Manupatra, South Asia Archive, Foreign Policy, GLHEL, URKUND etc. The library remains open from 9:00 am to 04:40 pm on working days and it is proposed to keep it open 24*7.

SLHSS also has a specialised library dedicated to cater the needs of students, faculties and research scholars related to criminal justice administration. To forward e-learning, SLHSS has access to several online database viz SCC, Jstor and so on.

SLHSS proudly holds the membership of several International and National Institution of repute and it also has access to their online and offline database consisting of academic literature and research material for further study.

Careers

- A focused, coordinated & concerted approach towards internship & placement with long term career development.
- Internships & placements with international and national law firms, Supreme Court of India, High Courts, Senior Advocates, Union and State Government Departments, Tribunals, national and state PSUs, LPOs, Banks, corporate houses, think-tanks, NGOs.
- Special classes will be taken by senior faculties, professionals for UGC NET, Judicial & Police recruitment examination from time to time.
- Weightage of additional marks in Gujarat Police recruitment shall be given to the candidates possessing any degree or post graduate diploma certificate awarded by Rashtriya Raksha University

Scholarship and Financial Assistance

- **Tuition fees waiver** : Program fee reimbursement for 10% enrolled students based on need-cum-merit against rendering research, administrative assistance, etc.
- **Stipend for career development of students** : Monthly stipend for one year to 10% enrolled students upon completion of education based on rigorous selection criteria.
- **Student Development & Research Initiatives**
 1. Several research and other administrative assistance scholarship may be made available throughout the year.
 2. Limited financial assistance for presentation of research papers in international and national conferences and seminars.
- **Entrepreneurship Opportunities**: The students can avail entrepreneurship opportunities in the form of start-up, incubation support available throughout the year from the School.
- **Student Research Development Fund**: SLHSS shall offer Students Research Development Fund for promoting research culture.
- **International Immersion Program** shall be offered for the students and faculties for the overall growth in the field of Training, Research, Education and Extension (TREE).

N.B.

- In case of cancellation of Admission within two weeks, 10% of the Programme Fee shall be deducted and after that no fee shall be refundable. The date of admission shall be determined from the date of payment of the programme fee.
- ₹ 5000 shall be charged as Professional Assistance Fee to facilitate job/placement opportunity by the university. This is optional and not mandatory.
