General Term & Conditions:

- 1. The Contract shall be awarded initially for a period of one year which shall be effective from the date of award of workorder. However, RRU at its discretion, may extend the contract next subsequently years (Maximum: 2 Years) subject to satisfactory performance of the bidder in the preceding year and the terms & conditions mutually agreed thereof.
- 2. AMC will include visits once every two months & it includes preventive and corrective maintenance services, necessary repair & maintenance, without any additional cost except equipment/part damaged due to human error or fluctuation of voltage or for any other unforeseen reason.

- 3. The Technician after every visit, shall submit report giving complete details of all the equipment viz., equipment condition, indicative durability and requirement or replacement of the equipment, if any.
- 4. In case it is observed at any time during the AMC that the selected Vendor is not fulfilling the terms & conditions and/or statutory compliances, RRU, Gandhinagar may terminate the Contract summarily and debar/blacklist the vendor from participating in any future activity of the RRU, Gandhinagar.
- 5. Bidders are required to quote all-inclusive consolidated rates for the Annual Maintenance Contract (AMC) including GST.
- 6. RRU, Gandhinagar will make payment to the selected vendor upon successful completion of every four months. No advance payment will be made to the selected vendor in any circumstance. Bidders are advised to go through the list of equipment as well as visit the site before submitting their bids.
- 7. Bidders are requested to submit their financial strength
- 8. Bidders are requested to submit duly signed experience regarding AMC of Gym Equipment
- 9. Bidders must submit their company registration
- 10. Bidders must submit GST and PAN details
